Upcoming Meetings:

The next General Meeting is scheduled for Wednesday, 18 May 2024 at the China Buffet Restaurant, in Warner Robins Georgia. Our speakers will be Maj Chad Hypes and Maj Jonathan McKnight as they present the latest 116 CEG Program Overview. This is always one of our more popular presentations as we hear about work ongoing and upcoming in support of the 116 AEW mission.

Programs/Program News:

Mr. Joe Ballard provided a copy of the 2024 and preliminary 2025 schedule of programs on 13 September 2024. The program schedule is attached to these minutes.
